

ORDINANCE 2006-17-CM

WHEREAS, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the regulatory signs, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices; and

WHEREAS, the Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule III & IV, Traffic Schedule regarding Yield and Stop Intersections of the Tippecanoe County Code of Ordinances to incorporate and include the following regulatory signs and to re-adopt Chapter 72, Schedule III & IV as so amended; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County Indiana that the regulatory signs at the following intersections shall be established as follows:

1. The Tippecanoe County Code Chapter 72, Schedule III & IV Traffic Schedule regarding Yield Intersections and Stop Intersections, be amended to add thereto the following regulatory signs and re-adopt as so amended:
 - 1.) Replace existing Yield sign with a 30" High Intensity Stop sign on Newcastle Road at East County Line Road
 - 2.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 1000 East at County Road 700 South
 - 3.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 1000 East at Newcastle Road
 - 4.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 1000 East at County Road 1000 South
 - 5.) Install a 30" High Intensity Stop sign on Hoover Road at County Road 350 North
 - 6.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 600 West at County Road 350 North
 - 7.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 625 West at County Road 1000 South
 - 8.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 1225 South at County Road 625 West
 - 9.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 1240 South at County Road 625 West
 - 10.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 350 West at County Road 1200 South
 - 11.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 350 West at County Road 1300 South
 - 12.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 350 West at South County Line Road
 - 13.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 925 South at County Road 200 West
 - 14.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 375 West at County Road 500 North
 - 15.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 425 West at County Road 600 North
 - 16.) Replace existing Yield signs with 30" High Intensity Stop signs on County Road 375 West at County Road 600 North


- 17.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 400 West at County Road 750 North
 - 18.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 350 West at County Road 850 North
 - 19.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 150 South at County Road 900 East
 - 20.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 150 South at County Road 650 East
 - 21.) Replace existing Yield sign with a 30" High Intensity Stop sign on East County Line Road at County Road 350 South
 - 22.) Replace existing Yield sign with a 30" High Intensity Stop sign on East County Line Road at County Road 200 South
 - 23.) Replace existing Yield sign with a 30" High Intensity Stop sign on County Road 50 South at County Road 675 East
 - 24.) Replace existing Yield sign with a 30" High Intensity Stop sign on East County Line Road at County Road 100 South
 - 25.) Revise County Code Traffic Schedule III to include Stop signs on County Road 500 East at Old County Road 350 South. 30" High Intensity Stop signs are currently present at this intersection but are not reflected in the Traffic Schedule.
 - 26.) Revise County Code Traffic Schedule III to include Stop signs on Old County Road 350 South at Newcastle Road. A 30" High Intensity Stop sign exists at this intersection but not reflected in the Traffic Schedule.
 - 27.) Revise County Code Traffic Schedule IV to delete the Yield sign on County Road 50 South at County Road 550 East. A 30" High Intensity Stop sign exists at this intersection and is listed in Traffic Schedule III.
 - 28.) Revise County Code Traffic Schedule III to include Stop signs on County Road 100 South at County Road 1025 East per Ordinance 95-20CM and revise County Code Traffic Schedule IV to delete the Yield signs at this intersection. 30" High Intensity Stop signs are currently present at this intersection.
 - 29.) Revise County Code Traffic Schedule III to delete the Stop sign listed on County Road 350 South .723 miles east of US 52. This Stop sign was removed due to changes to the roadway when the new County Road 350 South was constructed.
2. The Sheriff's Department is to be notified of all the above traffic control installations and changes.
 3. A person who violates the regulation set forth in this Ordinance commits a Class C infraction.

AND BE IT FURTHER ORDAINED that the effective date of this action shall be September 11, 2006.
