

ORDINANCE NO. 2013 – 40 - CM
AMENDING TIPPECANOE COUNTY CODE
CHAPTER 72, SCHEDULE I
Traffic Schedule regarding Speed Limits

WHEREAS, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the speed regulations, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices; and

WHEREAS, The Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule I, Traffic Schedules regarding Speed Limits of the Tippecanoe County Code of Ordinances to incorporate and include the following regulations and to readopt Chapter 72, Traffic Schedule I, as so amended; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that:

1. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to delete the following and re-adopted as so amended:

Jackson Highway	From CR 475 West to CR 350 North (east leg)	55	NA	2004-25-CM	7-19-04

2. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to include the following and re-adopted as so amended:

CR 450 North	From 800 feet east of CR 625 East to Ruffing Street (Buck Creek Town Limits)	40	NA	2013-40-CM	12-2-13
CR 475 West	From Jackson Highway to US 52	40	NA	2013-40-CM	12-2-13
Jackson Highway	From SR 26 to 3,400 feet west of CR 475 West	45	NA	2013-40-CM	12-2-13
Soldiers Home Road	Overlook Drive to Prophets Drive (City Limits to City Limits)	30	NA	2013-40-CM	12-2-13
Soldiers Home Road	Lorene Place (City Limits) to SR 43	35	NA	2013-40-CM	12-2-13

3. That in all other respects, the Tippecanoe County Code Chapter 72, Traffic Schedules be, and they are hereby ratified and confirmed and shall remain in full force and effect.

4. The Sheriff's Department shall be notified of all the above traffic schedule amendments and installation of related regulatory signs.

5. That all signs within Tippecanoe County that function to provide regulations, warnings and guidance information for road users, in both words and symbols, within the right-of-way of all types of highways open to the public shall conform to the latest edition of the Indiana Manual on Uniform Traffic Control Devices.

6. This Ordinance shall be in full force and effect on December 2, 2013.
