

ORDINANCE NO. 2014-25-CL

AMENDING ORDINANCES 2014-18-CL and 2014-20-CL
FIXING THE COMPENSATION OF ALL COUNTY OFFICERS,
DEPUTIES AND OTHER EMPLOYEES, AND FIXING THE NUMBER
OF DEPUTIES AND OTHER EMPLOYEES FOR EACH COUNTY OFFICE,
DEPARTMENT, COMMISSION, OR AGENCY

WHEREAS, the County Council of Tippecanoe County adopted Ordinance No. 2014-18-CL on October 14, 2014 and Amended Ordinance No. 2014-20-CL on November 12, 2014, fixing the compensation of all county officers, deputies, and other employees, and fixing the number of deputies and other employees for each county office, department, commission, or agency for the calendar year 2015, all in accordance with Indiana Code 36-2-5-11; and

WHEREAS, the County Council of Tippecanoe County, Indiana desires to amend Ordinances 2014-18-CL and 2014-20-CL by revising the exhibits attached thereto, as required to establish and fix salaries for the year 2015 for the Sheriff's Department Chief Deputy and Captain positions and to otherwise reaffirm said Ordinances as adopted.

NOW, THEREFORE, BE IT ORDAINED by the County Council of Tippecanoe County, Indiana, that Ordinances 2014-18-CL and 2014-20-CL be, and they are hereby amended as required to establish and fix salaries for the year 2015 for the Sheriff's Department Chief Deputy and Captain positions as reflected on the supplements to Exhibits A and C to said Ordinances in the form attached hereto.

BE IT FURTHER ORDAINED that in all other respects Ordinances 2014-18-CL and 2014-20-CL are ratified and confirmed.

This Ordinance shall be effective upon passage.




