

TIPPECANOE COUNTY COUNCIL
REGULAR MEETING
November 9, 2011

The Tippecanoe County Council met Wednesday, November 9, 2011 at 8:30 a.m. in the Tippecanoe Room of the County Office Building. Councilmembers present were: President Andrew S. Gutwein, Vice-President Roland K. Winger, John R. Basham II, Jeffrey A. Kemper, Kevin L. Underwood, Kathy Vernon, and David R. Williams. Others present were: Auditor Jennifer Weston, Attorney Doug Masson, and Secretary Dawn Rivera.

President Gutwein called the meeting to order and led the Pledge of Allegiance.

AUDITORS FINANCIAL REPORT – Jennifer Weston

Auditor Jennifer Weston reported a beginning net balance of \$1,100,815.88. Council has granted additional appropriations of \$378,734, reductions of \$85,119, and miscellaneous expenses of \$9,380.58, leaving an uncommitted balance of \$797,820.30. The total of all fund balances is approximately \$66 million, which is less than the balance of prior months, primarily due to payments for road and bridge work that concluded this summer.

TREASURER'S REPORT – Bob Plantenga

Auditor Weston explained that Treasurer Plantenga was in the Treasurer's office collecting tax payments with the deadline tomorrow. The report prepared by Treasurer Plantenga was distributed to members and reflects an increase of interest earned over the prior month of nearly \$8,000. The average interest rate is 0.98%; the weighted average dropped slightly from last month at 0.95 % to 0.93%.

RESOLUTION 2011-39-CL: SECOND AMENDMENT TO TIPPECANOE COUNTY POLICE RETIREMENT PLAN – Tracy Brown

Sheriff Brown introduced Stan Brown with McCreedy and Keene, Inc. to explain the changes to the retirement plan. Mr. Stan Brown explained that the changes with this amendment do not change the benefits of the plan, but re-states language to conform to IRS regulations. Technical fixes have been reviewed by County Attorney Luhman.

RESOLUTION 2011-42-CL: DECLARING ERA DESIGNATION AND APPROVING TAX ABATEMENT APPLICATION – AMERICAN FIBERTECH CORPORATION

Sascha Harrel, Greater Lafayette Community Development Corporation, introduced Jay Wiegand of American Fibertech Corporation to discuss the company's tax abatement application.

Mr. Wiegand spoke on behalf of American Fibertech stating its intention to invest in capital improvements for real estate and machinery and equipment. The dollar amount of investment is presented in a range of \$3.5 - \$5.0 million because they are unsure of the progress at this time, but hope to have a 80,000 - 90,000 square foot facility when finished in five years. Mr. Wiegand extended an invitation to other Council members to visit the plant.

Councilmembers Gutwein and Winger expressed concern of the timeline of the length of the abatement since the project completion dates are not yet established. Attorney Luhman noted that the Council could add additional restrictions that the Application for Deduction be filed within a certain time period, such as a year or two, in order for the abatement to be granted so it is not open-ended. In any event, the abatement granted would not be longer than 10 years on the real estate.

- Councilmember Kemper moved to approve Resolution 2011-42-CL as presented, second by Councilmember Winger; motion passed.

PUBLIC DEFENDER**General Fund 001**

Public Defender Amy Hutchison requested the appropriation for full time funds to cover the reclassification/implementation of a Chief Deputy position within the office. The overtime is needed for work on a potential death penalty case, which should occur before year-end. The part time request was withdrawn.

Commissioner David Byers made the following announcements:

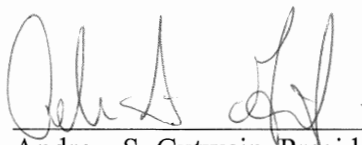
- The courthouse window project should be wrapping up in November, although storm windows are scheduled for installation in January.

Paul Wright, *West Point* – expressed concern about the blanket raise for all employees, that while the County may have the money right now, the increase goes to the base salary and is not the same as a bonus, in which every taxpayer has to pay. He also expressed concern that the Council voted for insurance coverage. President Gutwein explained that the Council did not vote to expand or change insurance coverage – the coverage is the same as it has been in the past.

Meeting adjourned by consensus.

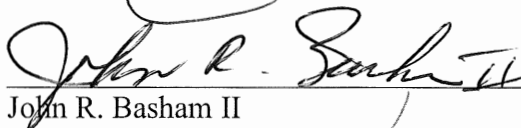
