REGULAR MEETING
November 12, 2008

The Tippecanoe County Council met at 10:00 a.m. Wednesday, November 12, 2008 in the Tippecanoe Room in the County Office Building. Council members present were: President Thomas P. Murtaugh, Vice President Kevin Underwood, Betty J. Michael, Andrew S. Gutwein, Jeffrey R. Kemper, David S. Byers, and Kathy Vernon. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

President Murtaugh called the meeting to order and led the Pledge of Allegiance.

ORDINANCE FOR APPROPRIATION AND TAX RATES 2009: 2nd Reading

Auditor Weston explained the Ordinance for Appropriation and Tax Rates for 2009 was approved on first reading August 25th, 2008. She added the county has reached the maximum levy of 4%; property tax related funds cannot exceed the maximum levy. Department budgets have been revised with the exception of salary adjustments. Auditor Weston reported \$6,720,991 is to be received for COIT, which made the total revenue estimate \$37,266,771. She suggested any remaining funds be allocated into the Juvenile Center line item. At Budget Hearings, two options were presented for the council to consider; a 2% raise for all employees or a designated percentage for different ranges as suggested by Waggonner, Irwin, and Scheele.

- Councilmember Gutwein moved to appropriate any excess funds to include additional COIT funds be added to the new line item for the Juvenile Center, second by Councilmember Vernon; motion carried.
- Councilmember Byers moved to approve the salary charts as presented, second by Councilmember Michael; motion carried.

Councilmember Kemper gave details regarding the County Assessors' plans to transfer the 2009 Fairfield budget to the corresponding County Assessor budget. County Assessor Samantha Steele confirmed she will have 20 full-time (10 full-time from General Fund, 6 from Reassessment Fund, and 4 proposed employees from the Fairfield office to be paid from the three various funds) employees starting in 2009 to be funded from the Reassessment, Sales Disclosure, and General Funds. Auditor Weston explained the amount to be rolled is as follows:

Sales Disclosure Fund 285 - \$10,765

Reassessment Fund 281 - \$18,301

General Fund 001 - \$170,104

- Councilmember Gutwein moved to approve the transfer of previously allocated funds from the Fairfield Township Assessor, except \$1, to the County Assessor to fund the positions as set-forth by the organizational chart with any excess funds transferred to the Juvenile Center line item, second by Councilmember Underwood; motion carried.

RESOLUTION 2008-41-CL; CONFIRMS MENTAL RETARDATION 2009 Funding

Resolution 2008-41-CL confirms the funding for Mental Retardation Centers at a rate of \$.01 per \$100. The rate is unchanged from last year.

RESOLUTION 2008-42-CL; CONFIRMS 2009 FUNDING OF COMMUNITY MENTAL HEALTH

Resolution 2008-42-CL confirms the 2009 funding for Community Mental Health at a fixed amount of \$856,148.

RESOLUTION 2008-43-CL; CONFIRMS & RATIFIES 2009 SALARY OF COUNTY CORONER

Resolution 2008-43-CL confirms the 2009 salary of the County Coroner at \$39,540 as a licensed Physician.

RESOLUTION 2008-44-CL; CONFIRMS & RATIFIES 2009 SALARY OF COUNTY SURVEYOR

Resolution 2008-44-CL confirms the 2009 salary of the County Surveyor \$83,147 as a licensed Surveyor.

- Councilmember Michael moved to approve Resolution 2008-44-CL, second by Councilmember Vernon; motion carried.

RESOLUTION 2008-45-CL; AMENDING EDIT PLAN – ADDITIONAL FUNDING PROJECT 42 JUVENILE FACILITY

Resolution 2008-45-CL endorses an amendment to the EDIT Plan to include Project 42 Juvenile Justice Center. The amendment approved on October 20, 2008 by the commissioners includes the funding for the acquisition of the real estate and construction of the facility and reflects the anticipation of issued bonds in the amount of \$19,500,000 to fund the project. EDIT revenues will provide the debt service for the bond issue.

- Councilmember Kemper moved to approve Resolution 2008-45-CL, second by Councilmember Michael; motion carried.

ORDINANCE 2008-18-CL – 2ND READING; JUVENILE CENTER BOND ORDINANCE

Attorney Luhman confirmed Ordinance 2008-18-CL, authorizes the issuance of bonds for the Juvenile Center not to exceed \$19,500,000 for construction of the facility. The bonds are payable over 20 years not to exceed 6% interest rate. Mr. Luhman suggested the council consider amending the maximum interest rate not to exceed 8% due to the fluctuation of the current market.

- Councilmember Byers moved to approve Ordinance 2008-18-CL amended not to exceed a maximum of 8% interest on second reading, second by Councilmember Michael; motion carried.

ORDINANCE 2008-19-CL – 2ND READING; JUVENILE CENTER ADDITIONAL APPROPRIATION

Attorney Luhman stated Ordinance 2008-19-CL appropriate the proceeds of the bonds for use in payment of the Juvenile Center.

Public Comment

Joe Venable, representative of NAMI of Indiana, commended the council for continuing on the Juvenile Center. He believes the center will be an investment in the community and not an expense that will need minimized in the future.

Councilmember Byers thanked the Council, Commissioners, developers, and Rebecca Humphrey for their commitment to the Juvenile Center project. He agrees the Juvenile Center will be an investment in the community rather than an added expense.

YOUTH SERVICES UPDATE – Rebecca Humphrey

Director Rebecca Humphrey commended the Council for their commitment to the Juvenile Center project. She thanked the Council for the encouragement and for holding the stakeholders accountable for all their actions on behalf of the citizens of Tippecanoe County. Director Humphrey confirmed Youth Services of Tippecanoe County will do the Council, community and the children proud in Tippecanoe County.

Construction documents for the Juvenile Center were approved by the Commissioners and will be available at the Pre-Bid meeting on November 20, 2008 and bids will be received on December 11, 2008. Closing on the land will be November 26, 2008.

VETERAN'S SERVICE – Randy Fairchild

Director Randy Fairchild thanked the Council for helping to fund the Disabled Veteran's van. Mr. Fairchild was able to raise the funds needed to purchase the van and is returning the funds to the county. The old van will also be returned to the county.
