

TIPPECANOE COUNTY COUNCIL
REGULAR MEETING
October 9, 2007

The Tippecanoe County Council met at 2:00 p. m. Tuesday, October 9, 2007 in the Tippecanoe Room in the County Office Building. Council members present were: Vice President Thomas P. Murtaugh, Andrew S. Gutwein, David S. Byers, Betty J. Michael, Kevin Underwood, and Kathy Vernon. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

Vice President Murtaugh called the meeting to order and led the Pledge of Allegiance.

APPROVAL OF MINUTES

- Councilmember Michael moved to approve minutes from the July 24, 2007 and September 11, 2007 meetings, second by Councilmember Byers; motion carried.

AUDITOR FINANCIAL REPORT – Jennifer Weston

Auditor Weston reported the cash fund balance of the General Fund is usually negative this time each year until December settlement is received. At this time, she is projecting the cash balance January 2008 will be \$3.7 million.

Auditor Weston spoke regarding the Department of Corrections bills. She informed the council that \$700,000 has been appropriated for 2007 and to date half of total budget has been spent. These expenses were incurred in last quarter of 2006 and after payment is made on the first two quarters of 2007, there will be an outstanding balance due of \$129,000. Auditor Weston projects the amount of funds needed for 2007 is an additional \$360,000.

TREASURER'S REPORT – Bob Plantenga

Treasurer Plantenga noted interest rates remain the same from last year. The General Fund balance is low without property taxes carrying over however, with the impending tax sale the balance will increase.

SUPERIOR COURT

Sex Offender Management Grant Fund 236

Dr. JoAnn Miller requested a grant appropriation for a Sex Offender Management Grant. This program will manage sex offenders that return to the community after they are released from prison.

Judge Busch updated the council regarding cost for the county to hire a special Prosecutor. He reported Rob Ives from Carroll County accepted the cases for defendants previously affiliated with Prosecutor Pat Harrington. Judge Busch acknowledged billing for services across all courts has been an issue and to date services have totaled \$32,474.98. These expenses will be paid from un-appropriated funds as the law stipulates.

Director Cripe explained a five year grant was awarded to Tippecanoe County from North Central Health Services in 2005. The grant is awarded each year for \$75,000 for chronic disease data collection for Tippecanoe County and surrounding counties.

Human Resource Director Shirley Mennen requested an additional appropriation of \$500,000 for employee benefits and health insurance. Her request will cover a deficit of \$50,000 for employee health claims and provide funds for claims in 2007.

FLEX PLAN DISCUSSION – Shirley Mennen

Director Mennen recommended the council consider Flex Plan Benefits for employees that do not elect health coverage in 2008. The \$120 benefit per employee was cut at budget hearings and employees electing health coverage had the option to receive a \$120 reduction in premium if the Health Risk Assessment was completed. In an effort to provide equal benefits to all employees, the county would establish a Flex Spending Account for use by designated employees not receiving health coverage from the county. Director Mennen reported approximately 54 employees did not elect medical coverage in 2007 and she estimated the cost to be \$6,000.

ORDINANCE 2007-37-CL – PAYMENT OF PARKING FEES PAID BY JURORS

Attorney Luhman described Ordinance 2007-37-CL; Payment of Parking Fees Paid by Jurors. This ordinance will allow the county the option of providing parking in county owned lots in lieu of mileage payments.

- Councilmember Byers moved to approve Ordinance 2007-37-CL, second by Councilmember Gutwein;

DEPARTMENT OF CHILD SERVICES – Angela Smith Grossman

Director Angela Smith Grossman requested a \$1 million temporary loan for the Department of Child Services. She reported the department currently has \$770,000 in outstanding bills through the end of October and she plans to use the loan to pay bills incurred in that timeframe. Director Grossman will use the December tax draw to repay the county and become current with November and December bills.

YOUTH SERVICES UPDATE – Rebecca Humphrey

Director Humphrey provided handouts regarding the Third Annual Child Abuse Summit. The League of Women Voter's will be sponsoring a forum on the Youth Center on February 25, 2008 at 7:00 p.m. Evidenced based practices implemented recently by Probation are Youth Level of Service Inventories/Case Management Inventories to assist youth placement in the proper services. Aggression Replacement Training has been implemented by Juvenile Alternatives Director Tammy Patrick through a Tippecanoe County Corrections Grant. Director Humphrey has created a Girls Circle Group at no cost to taxpayers. The Purdue Education staff is exploring resources for free mental health counseling for adolescents and career exploration. LARA has offered free GED services for the youth center detainees as well as children participating in alternative services. Beacon Academy is interested in providing alternative education in the youth center. Director Humphrey plans to discuss a possible partnership with Community Health Clinic and the Youth Center.
