

**TIPPECANOE COUNTY COUNCIL**  
**REGULAR MEETING**  
*May 15, 2007*

The Tippecanoe County Council met at 2:00 p. m. Tuesday, May 15, 2007 in the Tippecanoe Room in the County Office Building. Council members present were: President Jeffrey A. Kemper, Vice President Thomas P. Murtaugh, David S. Byers, Andrew S. Gutwein, Betty J. Michael, Kevin Underwood, and Kathy Vernon. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

President Kemper called the meeting to order and led the Pledge of Allegiance.

***APPROVAL OF MINUTES***

- Councilmember Byers moved to approve minutes from the April 10, 2007 regular meeting, second by Councilmember Vernon; motion carried.

***AUDITOR'S REPORT – Jennifer Weston***

Auditor Weston presented a General Fund Financial Statement for April 2007.

She noted that the Cary Home JAMS grant fund 132 has a negative balance. In 2005, county council approved funding for JAMS employees out of the general fund; however the employees remained paid out of the grant funds. She may approach the council in the future for additional appropriations to correct the fund balances.

***TREASURER'S REPORT – Bob Plantenga***

Treasurer Plantenga noted that interest rates remain the same. Interest from the Cumulative Bridge Fund will deposit into the Cumulative Bridge Fund starting in May through December. He added that the interest generated from property taxes will be slightly lower due to the delay in tax bills.

***COMPLIANCE W/ STATEMENT OF BENEFITS (CF-1) – Roadworks***

Susan Linson, President, spoke on behalf of Roadworks. She stated that business is going well, currently there are 36 employees on the payroll. Business is slightly sluggish compared to last year, but noted that the transportation industry is slow as well. She added that plans for 2007 include adding new jobs with new product implementation.

- Councilmember Murtaugh moved to find Roadworks compliant with the statement of benefits, second by Councilmember Michael; motion carried.

***SUPERIOR COURT 3 –Kathy Timberlake and Rebecca Humphrey***

Youth Services Director Rebecca Humphrey requested the additional appropriation for the FOCUS Program be withdrawn. Ms. Humphrey stated that alternative funding sources may be available and noted that Superior Court 3 will research the possibilities.

Kathy Timberlake requested funds for an additional part time position for the juvenile magistrate. She added that the part time help will ease the workload in the magistrate's office.

- Councilmember Byers moved to approve the salary statement to include part time, second Councilmember Michael; motion carried.

***JUVENILE DRUG TREATMENT COURT FUND 156***

Kathy Timberlake requested approval for an additional appropriation for a collaborative grant between Superior Court 3, Youth Services and the Community and Family Resource Center. This grant will fund the drug court case management program.

***HEALTHY YOUTH DEVELOPMENT FUND 642***

Kathy Timberlake requested additional appropriations for the Healthy Youth Development grant. This grant will serve 1200 youth in Tippecanoe County and help identify gaps in youth services and the mental health service continuum. Funds will aid in the implementation of an evidence based parenting group titled "Staying Connected to Your Teen". She added that it will also support the computerized programming for the youth level of service inventory (YLSIR). This program will identify the risk level of children and the various services needed for youth returning from probation.

- Councilmember Murtaugh moved to approve additional appropriations for Fund 642, second by Councilmember Underwood; motion carried.

***FAMILY COURT GRANT FUND 628***

Kathy Timberlake also requested additional appropriations for a continuation grant. She noted that the grant will fund both Superior Court 3 and Circuit Court. The Superior Court 3 portion will fund the drug treatment court for case management for the entire family. The Circuit Court portion will aid the adult family court coordination with service referral for high risk families, coordination of multiple case families and mediation services.

- Councilmember Michael moved to approve the additional appropriations for Fund 628, second by Councilmember Gutwein; motion carried.

**COMMISSIONERS**

Commissioner's Assistant Frank Cederquist requested additional appropriations for part time help to cover a full time employee on medical leave in Human Resources. A portion of the funds are also for a current part time employee that assists in Human Resources and the Commissioner's office.

**Additional Appropriation: \$10,795**

- Councilmember Byers moved to approve the additional appropriation as stated, second by Councilmember Vernon; motion carried.

***WABASH ASSESSOR – Janet Freels***

Assessor Janet Freels requested an additional appropriation for a full time Real Estate Deputy. New Construction and yearly trending are factors in the increased workload. She added that her part time funds have been depleted and suggested a full time position be created to assist in all areas of the Wabash Assessor's office.

Councilmember Byers stated he has witnessed the workload and spoke with Assessor Freels regarding her request. He supports her request and added that he would prefer the position be funded from the reassessment fund. Auditor Weston noted that the request was not advertised out of reassessment because it was not presented as a recommendation from the county assessor. Councilmember Byers will arrange a meeting between the assessors to organize and budget the reassessment funds for the 2008 budget.

***PROSECUTOR – Pat Harrington*****Old Hoosier Fund 250**

Prosecutor Harrington requested additional appropriations for Adult Protective Services (APS). The budget did not include travel pay for APS investigators. Also, he noted that the investigators are in the field 80% of the time and laptops are needed to perform the work in a timely and efficient manner.

**Criminal Justice Grant Fund 601**

An additional appropriation was requested by the prosecutor's office for the Drug Task Force to purchase computers and software.

**Prosecutor IV-D Incentive Fund 256**

Prosecutor Harrington requested a transfer for funds misappropriated earlier in the year.

***TIPPECANOE VILLA – Deanna Sieber***

Director Deanna Sieber requested a transfer for unexpected repairs at the Villa. She noted that the bath tub/shower in the women's area of the Villa was repaired several times and now is in need of replacement.

- Councilmember Michael moved to transfer funds as stated, second by Councilmember Byers; motion carried.

***HEALTH DEPARTMENT – Colleen Batt***

WIC Director Colleen Batt requested a transfer for unexpected expenses. She noted that next month she will request additional funds to cover the increase for the budget revision for 2008 in the amount of \$249,393.

**Transfer: \$18,000**

\$18,000 General Operating/Misc to Supplies

- Councilmember Byers moved to approve the transfer as stated, second by Councilmember Murtaugh; motion carried.

***AUDITOR – Jennifer Weston***

Auditor Weston requested a transfer of appropriations for additional office equipment. With two positions unfilled, she noted that unused funds are available.

**Transfer: \$9,000**

\$9,000 Salaries/Full Time to Office Expense/Supplies

- Councilmember Vernon moved to approve the transfer as stated, second by Councilmember Gutwein; motion carried.

***COUNTY COUNCIL***

Councilmember Byers noted that Greg Guerrattaz, the county's financial consultant, suggested these funds be transferred.

**Transfer: \$250,000**

\$250,000 General Fund to Rainy Day Fund

- Councilmember Gutwein moved to approve the transfer from the General Fund to the Rainy Day Fund, second by Councilmember Byers; motion carried.

***PART-TIME RATES – Jennifer Weston***

Auditor Weston presented a list of part time hourly rates for part time employees. She noted that the list shows those rates already approved for 2007 and those being proposed for approval in order to have accurate salary statements.

- Councilmember Michael moved to approve the Part Time Rate schedule for 2007, second by Councilmember Murtaugh; motion carried.

***COURT SERVICES – Cindy Houseman***

Director of Court Services Cindy Houseman presented a review of court services. She noted that budget revisions were made in 2006 to reflect loss of revenue. In 2006, court services lost 40% of their yearly revenue, and in 2007 regained 17% due to creative marketing. Director Houseman briefly outlined a 2007 budget and future plans to regain revenue by adding additional programs.

**OTHER BUSINESS**

Auditor Weston briefly recapped the discussion with the county's financial planner. She noted that originally the CEDIT homestead credits for a few districts were high compared to other district rates in Tippecanoe County. After working with the State Auditor's Office and the County Treasurer a new method was used to allocate those credits more equitably among the districts.

**YOUTH SERVICES UPDATE – Rebecca Humphrey**

Director Rebecca Humphrey presented statistics on youth in Tippecanoe County. She currently is investigating various youth services at the courthouse and how they may be relocated to better serve the youth. She is also researching co-location of Cary home, alternative services and secure detention sites.

**COMMISSIONERS FYI – KD Benson**

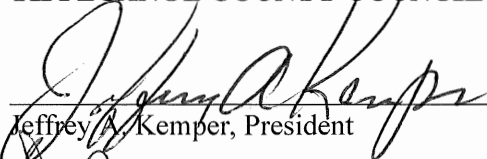

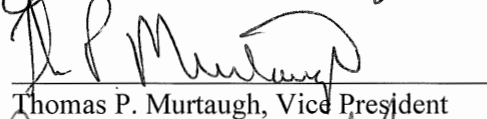
**PUBLIC COMMENT**

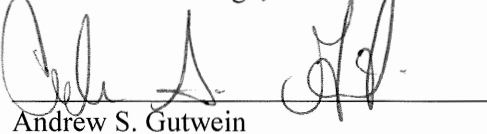
