

COUNTY OF TIPPECANOE
ORDINANCE NO. 2005-37-CM
VACATING STREETS AND ALLEY IN THE
UNINCORPORATED TOWN OF MONROE,
LAURAMIE TOWNSHIP, TIPPECANOE COUNTY, INDIANA

WHEREAS, Cheryl Afford f/k/a Cheryl Biddle has filed a petition to vacate a certain portion of Darlington Street and Fayette Street and a certain unimproved alley in the unincorporated town of Monroe, Lauramie Township, Tippecanoe County, Indiana; and

WHEREAS, proper notice was given to all abutting land owners; and

WHEREAS, a public hearing was held on Monday, November 1, 2004 at 10:00 a.m. on the petition and again on Tuesday, September 6, 2005 at 10:00 a.m.; and

WHEREAS, Darlington Street and Fayette Street and the unimproved alley are grassy areas that have not been used or maintained by the State or County; and

WHEREAS, the Board of Commissioners have determined that the petition is in good order and should be granted;

NOW, THEREFORE, BE IT ORDAINED, that all that part of Darlington Street located on the Northwest corner of lots forty-two (42), forty-three (43) and forty-four (44) from the south lot-line of lot number forty-two (42) to Fayette Street shall be and hereby is vacated; and

BE IT FURTHER ORDAINED, that all that part of Fayette Street located on the Northwest corner of lots twenty-one (21) and forty-four (44) from U.S. 52 South to Darlington Street, shall be, and hereby is vacated; and

BE IT FURTHER ORDAINED, that all that part of the unimproved alley that runs through lots forty-three (43) and twenty-two (22) from U.S. 52 South to Darlington Street, shall be and hereby is vacated.

Provided, however, that no part of the right-of-way of U.S. Highway 52 shall be vacated by this ordinance.

This ordinance shall be in full force and effect immediately upon its passage and signing.


