

TIPPECANOE COUNTY COUNCIL ORDINANCE NO. 2006-25-CL

AN ORDINANCE APPROPRIATING THE PROCEEDS OF
THE TIPPECANOE COUNTY WELFARE NOTE OF 2006

WHEREAS, the County Council ("Council") of Tippecanoe County, Indiana ("County") has received a resolution from the Department of Child Services authorizing the Tippecanoe County Office of Family and Children ("Office") to seek a loan from the County for the purpose of paying for services to be provided by the Office, due to insufficient funds on deposit in the County Welfare Fund and the County Family and Children Fund in accordance with IC 12-19-5;

WHEREAS, the Council has adopted a resolution authorizing the Office to borrow funds for the purpose of paying for those services and authorizing the County Auditor to negotiate a loan in an amount not to exceed \$3,000,000 ("Loan") to provide such funds; and

WHEREAS, the Council has published notice in accordance with IC 5-3-1 and held a public hearing regarding the appropriation of the proceeds of the Loan;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF TIPPECANOE COUNTY, INDIANA AS FOLLOWS:

1. (a) An appropriation in the amount not to exceed Three Million Dollars (\$3,000,000) is hereby made; and that the funds to meet this appropriation be provided out of the proceeds of the Loan. This appropriation is in addition to all other appropriations provided for in the existing budget and tax levy of the County for the current year.

(b) The fiscal officer of the County is hereby authorized and directed to provide information to the Department of Local Government Finance concerning this appropriation.

2. This ordinance shall be effective upon passage.
