

ORDINANCE NO. 2009-03-CM
AMENDING TIPPECANOE COUNTY CODE
REPEALING SECTION 31.107
ADDING NEW SECTION 31.107

MEMBERSHIP OF THE TIPPECANOE COUNTY MANAGEMENT
INFORMATION TECHNOLOGY SERVICES ADVISORY BOARD

WHEREAS, Indiana Code 36-1-3.5-9 authorizes the legislative body of governments to establish a County Data Processing Agency; and

WHEREAS, the Board of Commissioners of the County of Tippecanoe, State of Indiana, the legislative body of said County has previously established a Tippecanoe County Management Information Technology Services Department and Management Information Technology Services Advisory Board pursuant to Ordinance No. 83-4-CM, as amended, currently codified as Tippecanoe County Code Chapter 31, Sections 105, *et seq.*; and

WHEREAS, the Board of Commissioners of Tippecanoe County desires to amend the membership of the Tippecanoe County Management Information Technology Services Advisory Board to provide broader representation of county departments using information technologies.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that the Tippecanoe County Code be amended to repeal Section 31.107 add a new Section 31.107 reading as follows:

§ 31.107 MEMBERSHIP.

The membership of the Board shall consist of:

1. Permanent voting members.
 - a. All of the County Commissioners
 - b. Two members of the County Council to be determined by vote of the County Council.
 - c. The County Auditor
 - d. The County Treasurer.
 - e. The County Clerk
 - f. The County Assessor
 - g. One representative from a County Court or other County department to be recommended by the MITS director and determined by vote of the remaining membership.

2. Non-voting ex-officio member.
 - a. The director of the County Management Information Technology Services Department.


This Ordinance shall be in full force and effect immediately upon its passage and signing.
