

ORDINANCE NO. 2010 - 08 - CM
AMENDING TIPPECANOE COUNTY CODE
CHAPTER 72, SCHEDULE I & II
Traffic Schedule regarding Speed Limits and Weight Limits

WHEREAS, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the speed regulations and weight limits, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices; and

WHEREAS, The Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits of the Tippecanoe County Code of Ordinances to incorporate and include the following speed regulations and to readopt Chapter 72, Schedule I as so amended; and

WHEREAS, The Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule II, Traffic Schedule regarding Weight Limits of the Tippecanoe County Code of Ordinances to delete the following weight limit regulations and to readopt Chapter 72, Schedule II as so amended:

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that:

1. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to delete the following and re-adopted as so amended:

CR 450 East	From US 52 to CR 900 South	45	NA	99-18-CM	5-3-99

2. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to include the following and re-adopted as so amended:

CR 450 East	From CR 900 South to City of Lafayette Limits (south of US 52)	50	NA	2010-08-CM	6-7-10

3. The Tippecanoe County Code Chapter 72, Schedule II, Traffic Schedule regarding Weight Limits, be amended to delete the following and re-adopted as so amended:

CR 100 East	From 1,500 feet south of CR 500 South to CR 800 South	15 tons	See ordinance	98-29-CM	6/15/1998
CR 100 East	From CR 800 South to SR 28	15 tons	See ordinance	99-15-CM	5/3/1999
CR 500 East	From CR 200 South to CR 475 East	10 tons	See ordinance	99-16-CM	5/3/1999
Highway 1200 South	Between SR 43 and County Highway 400 West	14,000 pounds	See ordinance	80-11	6/23/1980

4. That in all other respects, the Tippecanoe County Code Chapter 72, Traffic Schedules be, and they are hereby ratified and confirmed and shall remain in full force and effect.

5. The Sheriff's Department shall be notified of all the above traffic schedule amendments and installation of related regulatory signs.

6. That all signs within Tippecanoe County that function to provide regulations, warnings and guidance information for road users, in both words and symbols, within the right-of-way of all types of highways open to the public shall conform to the latest edition of the Indiana Manual on Uniform Traffic Control Devices.


7. This Ordinance shall be in full force and effect on July, 7th 2010.






