

ORDINANCE NO. 2011-09-CM
AMENDING TIPPECANOE COUNTY CODE
REPEALING SECTION 122.20
ADDING NEW SECTION 122.20
HEALTH DEPARTMENT FEES AND CHARGES

WHEREAS, the Board of Commissioners desires to amend the uniform schedule of fees to be charged for those services provided by the Tippecanoe County Health Department;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that the Tippecanoe County Code be amended to repeal Section 122.20 and add a new Section 122.20 reading as follows:

§ 112.20 SCHEDULE OF FEES AND CHARGES.

There is hereby established the following uniform schedule of charges and fees which shall be charged and collected for services and products provided by the County Health Department:


This Ordinance shall be in full force and effect immediately upon its passage and signing.
