

ORDINANCE NO. 2012-35CL

AUTHORIZING ACCEPTANCE OF CREDIT CARDS  
TIPPECANOE COUNTY COMMUNITY CORRECTIONS

WHEREAS, Indiana Code 36-1-8-11 allows the Tippecanoe County Council, as the fiscal body of Tippecanoe County, to designate the financial instruments by which payments may be made to the County; and

WHEREAS, the Tippecanoe County Council desires to authorize the use of credit cards for the payment of all sums due Tippecanoe County Community Corrections for goods and services provided to adult and juvenile participants.

NOW THEREFORE BE IT ORDAINED by the Tippecanoe County Council that all sums now or hereafter due the County of Tippecanoe for goods and services provided to adult and juvenile participants in Tippecanoe County Community Corrections programs may be paid by bank card or credit card.

BE IT FURTHER RESOLVED, that if there is a vendor transaction charge or discount fee, whether billed to the county or charged directly to the county's account with respect to such credit card transaction, the county may collect from the person using the card a Credit Card User Fee for each such transaction, in an amount not to exceed the highest transaction charge or discount fee charged to the county by bank or credit card vendors during the most recent collection period.

BE IT FURTHER RESOLVED, that if the Credit Card User Fees collected pursuant hereto are insufficient to pay the total transaction charges or discount fees charged to the County by bank or credit card vendors, then the remainder of such charges shall be paid from the Project Income/User Fund subject to appropriation by the County Council.
