

ORDINANCE NO. 2012 – 05 - CM
AMENDING TIPPECANOE COUNTY CODE
CHAPTER 72, SCHEDULE I
Traffic Schedule regarding Speed Limits

WHEREAS, it has been determined by the Board of Commissioners of Tippecanoe County, through the Highway Engineering Department, upon the basis of an Engineering and Traffic Investigation, that the speed regulations, as listed below, are reasonable and safe and are in conformance with the Indiana Manual on Uniform Traffic Control Devices; and

WHEREAS, The Board of Commissioners of Tippecanoe County desires to amend Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits of the Tippecanoe County Code of Ordinances to incorporate and include the following speed regulations and to readopt Chapter 72, Schedule I as so amended; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that:

1. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to delete the following and re-adopted as so amended:

CR 300 North	From 1,800 feet west of CR 500 East to 1,700 feet east of CR 500 East	35	NA	2004-25-CM	7-19-04
CR 300 North	From CR 350 East to 1,800 feet west of CR 500 East	50	NA	2004-25-CM	7-19-04
CR 300 North	From SR 25 to CR 350 East	25	NA	2004-25-CM	7-19-04
CR 400 East	From CR 200 North to CR 300 North	40	NA	94-31-CM	8-15-94

2. The Tippecanoe County Code Chapter 72, Schedule I, Traffic Schedule regarding Speed Limits, be amended to include the following and re-adopted as so amended:

<i>Road/Street</i>	<i>Location</i>	<i>Speed limit (m.p.h.)</i>	<i>Temp speed (m.p.h.)</i>	<i>Ord.</i>	<i>Date</i>
CR 300 North	From 1,700 feet east of CR 500 East to CR 400E	45	NA	2012-05-CM	2-6-2012
CR 400 East	From CR200 North to Strawsma Drive	40	NA	2012-05-CM	2-6-2012
CR 400 East	From Strawsma Drive to CR 300 North	45	NA	2012-05-CM	2-6-2012

3. That in all other respects, the Tippecanoe County Code Chapter 72, Traffic Schedules be, and they are hereby ratified and confirmed and shall remain in full force and effect.

4. The Sheriff's Department shall be notified of all the above traffic schedule amendments and installation of related regulatory signs.

5. That all signs within Tippecanoe County that function to provide regulations, warnings and guidance information for road users, in both words and symbols, within the right-of-way of all types of highways open to the public shall conform to the latest edition of the Indiana Manual on Uniform Traffic Control Devices.


6. This Ordinance shall be in full force and effect on March 8, 2012.
