

ORDINANCE NO. 2013-47-CM
AMENDING TIPPECANOE COUNTY CODE
AMENDING SECTION 93.01 AND NEW SECTION 93.18
TIPPECANOE COUNTY FAIRGROUNDS FEES AND CHARGES

WHEREAS, the Board of Commissioners desires to adopt a uniform schedule of fees to be charged for use of facilities and grounds at the Tippecanoe County Fairgrounds;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that the Tippecanoe County Code be amended to delete §93.01 add a new §93.01 reading as follows:

§ 93.01 PURPOSE.

The purpose of this chapter is to specify the hours of operation for the Tippecanoe County Parks and Fairground and to regulate traffic and parking therein, and to establish a uniform schedule of fees for use of Fairgrounds facilities and services.

BE IT FURTHER ORDAINED by the Board of Commissioners of Tippecanoe County, Indiana, that the Tippecanoe County Code be amended to add a new §93.18 reading as follows:

§ 93.18 SCHEDULE OF FEES AND CHARGES.

There is hereby established the following uniform schedule of charges and fees which shall be charged and collected for use of facilities and grounds at the Tippecanoe County Fairgrounds:


