

**ORDINANCE NO. 2013-07-CL**

**ADDITIONAL APPROPRIATION  
CITYBUS**

**WHEREAS**, Indiana Code 6-1.1-18-5(j) and 6-1.1-18-20 require the Tippecanoe County Council (the Council) to adopt and approve the annual budget and tax levy of the Greater Lafayette Transportation Corporation d/b/a CityBus (Citybus) and;

**WHEREAS**, the Council has received and considered a Request for Additional Appropriation submitted by CityBus, a copy of which is attached hereto as Exhibit A; and

**WHEREAS**, the Council has determined that the proposed Additional Appropriation in the form attached hereto as Exhibit A is reasonable and necessary for the continued provision of services by CityBus and should be approved;

**NOW, THEREFORE, BE IT ORDAINED** by the County Council of Tippecanoe County, Indiana, that the Additional Appropriation for CityBus in the amount set forth on Exhibit A, attached hereto should be, and the same is hereby adopted and approved.

This Ordinance shall be in full force and effect immediately upon its passage and signing.
