

ORDINANCE NO. 2013-11-CL

**ADDITIONAL APPROPRIATION
TIPPECANOE COUNTY SOLID WASTE MANAGEMENT DISTRICT**

WHEREAS, Indiana Code 6-1.1-18-5(j) requires the Tippecanoe County Council (the Council) to adopt and approve the annual budget and tax levy of the Tippecanoe County Solid Waste Management District(TCSWMD) and;

WHEREAS, the Council has received and considered a Request for Additional Appropriation submitted by TCSWMD, a copy of which is attached hereto as Exhibit A; and

WHEREAS, the Council has determined that the proposed Additional Appropriation in the form attached hereto as Exhibit A is reasonable and necessary for the continued provision of services by TCSWMD and should be approved;

NOW, THEREFORE, BE IT ORDAINED by the County Council of Tippecanoe County, Indiana, that the Additional Appropriation for TCSWMD in the amount set forth on Exhibit A, attached hereto should be, and the same is hereby adopted and approved.
