

TIPPECANOE COUNTY COUNCIL
REGULAR MEETING
July 14, 2009

The Tippecanoe County Council met at 8:30 a.m. on July 14, 2009 in the Tippecanoe Room in the County Office Building. Council members present were: President Kevin Underwood, Vice-President Andrew S. Gutwein, Jeffrey R. Kemper, John R. Basham II, Roland K. Winger, Betty J. Michael and Kathy Vernon. Others present were: Auditor Jennifer Weston, Attorney David W. Luhman, and Secretary Jennifer Prange.

Councilmember Underwood called the meeting to order and led the Pledge of Allegiance.

APPROVAL OF MINUTES

Auditor Weston reported the General Fund has a negative balance due to a lack of property tax collections and the Jail Lease Rental Fund has a similar situation.

TREASURER'S REPORT – Bob Plantenga

Treasurer Plantenga reported interest rates are lower in May than any prior months in 2009. In May, all account interest amounts are down to due bank account expense fees.

SUPERIOR COURT 3 – Laurie Wilson

Sup 3 Near SHO Fund 517

Grant Facilitator Laurie Wilson reported the Indiana Criminal Justice Institute reduced the award amount from the initial grant request. Instead of funding a Part-Time Probation Officer, Superior Court 3 decided to use the funding for the Saturday School at Lafayette Jeff to reduce truancy and expulsions.

A Full-Time position is being requested to cover duties in both courts.

JUVENILE MAGISTRATE – Faith Graham

Juvenile Magistrate Faith Graham requested approval of a salary statement for a Full-Time Court Reporter position. The Magistrate explained the turnover for a Part-Time Court Reporter position is hampering the duties of her court. She would like to utilize her part-time funds with reimbursement for IV-D to fund a full-time position. If the council approves the Full-Time Court Reporter, the employee would also assume duties in Superior Court 3 which are normally covered by part-time employees. With Judge Rush re-allocating \$10,000 from part-time, adding reimbursements for IV-D hearings, and including part-time funds from the Juvenile Magistrate there will be a \$1,100 difference. She added if Performance Measure Incentive Funds received based on IV-D collections are also allocated to the IV-D Court there wouldn't be any additional funds requested to fund the position.






