Use this form when:

You are the Defendant in a criminal case and your case is completely finished, meaning:

- Your case has been dismissed in its entirety
- You had a trial and the trial resulted in a verdict, either not guilty or guilty
- You entered a plea of guilty and have been sentenced or you signed a Diversion Agreement with the Prosecutor's Office

NOTE: Cash bonds may be retained by the Court and applied to any and all fees ordered by the Court.

"Verified" means that by signing and submitting this Motion, you swear or affirm under oath and under penalties for perjury that all the answers and information are true and accurate.

**This form has both a Motion and an Order.**

- You must fully complete and sign the Motion.
- You must complete only the top half of the Order.
